- 1.7 Adjusts and repairs natural stone
- 1.8 Clears up the workplace

Core task 2: Organises the daily working duties of the colleagues

- 2.1 Apportions the working duties and instructs colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Consults and agrees with third parties
- 2.4 Monitors the progress
- 2.5 Reports to supervisor

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round stonemason positioning works in the masonry sector, consisting of small and medium-sized companies. The small companies are generally more specialised.

<p>structure</p> <p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. <p>Access to next level of education/professions</p> <p>With the certificate of professional training, transfer is possible to a middle management or specialist course (qualification level 4).</p> <p>After training, a diploma can be obtained in other specializations at level 3. In addition to broadening at level 3, it is possible to develop into a management position, such as planning officer or workshop manager. The All-round stonemason positioning can develop into the qualification for Supervisor construction, infrastructure and specialised contracting</p>	<p>International agreements</p> <p>The profession of All-round stonemason positioning is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p>Legal basis</p> <p>Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94802</p> <p>The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 year(s) (4800 study hours) (depending on previous education)</p>
<p>Entry requirements</p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
