3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Print media technician are:

Core task 1: Preparation and realisation of production

- 1.1 Plans his work on basis of order information and/or work instruction
- 1.2 Sets up workplace for production
- 1.3 Sets up the machine and operates it during and after the production
- 1.4 Ensures maintenance of the machine
- 1.5 Monitors the quality of the production process
- 1.6 Completes the work activities
- 1.7 Completes the administration and archives production data and/or files

Core task 2: Organisation and optimisation of production

- 2.1 Makes short-term production schedules and coordinates them
- 2.2 Manages basic workers and/or instructs them in the production
- 2.3 Solves technical problems
- 2.4 Comes with potential quality improvements for the production process
- 2.5 Manages courses of improvement
- 2.6 Designs workplace set-ups for the print media production

Core task 3: Preparation of digital printing

- 3.1 Makes stock available for production on machine in question
- 3.2 Oversees colour management

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Print media technician is employed by printing companies which produce printing matter in many different types and sizes: magazines, newspapers, house styles, brochures, catalogues, but also labels, wall paper, wrappings, printing of clothing and fabrics.

<p>Access to next level of education/professions The Print media technician can be transferred to higher vocational education. Potential courses at this level which match this profession are: graphic arts technology, industrial automation, business engineering and many other technical trainings. In his career as a Print media technician he can be promoted to be a foreman, shift manager rotation printing or finishing process or manager sheet fed printing, staff basic employee or basic employee company office; depending on the organisation structure of the company he works for.</p>	<p>International agreements The profession of Print media technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25210 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
