Core task 3: Strategically supervises the retail enterprise

- 3.1 Monitors the market position of the company
- 3.2 Makes operating and liquidity budgets
- 3.3 Determines the attention value and hospitality of the company
- 3.4 Maintains business contacts

3.5 Keeps abreast of trends and developments and innovates the company

Core task 4: Operationally supervises the retail enterprise

4.1 Is responsible for the implementation of the business administration

4.2 Organises the execution of the work

4.3 Presents and promotes the retail business

Within higher professional education, the Small business & retail management and/or Commercial economy would be logical options through which to develop. | International agreements The profession of Entrepreneur retail trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive. |

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25166 The education and training for this qualification is offered as of August 1, 2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
