- 1.4 Organize materials and means

Core task 2: Carries out work on and inside buildings and in direct vicinity

- 2.1 Prepare work that has to be done
- 2.2 Prepare (part of) building for work that has to be done
- 2.3 Perform maintenance working duties and working duties on building parts and building components
- 2.4 Monitor progress and quality working duties
- 2.5 Round off work on/inside buildings

**4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE**

The Constructional maintenance worker is employed in the maintenance sector. The position of maintenance employee is one that primarily goes with large multi-functional maintenance companies. The working duties are carried out in the sectors housing construction, non-residential construction, construction/renovation/redevelopment and the result-oriented real estate maintenance (RVO).

<b>Access to next level of education/professions</b> The Constructional maintenance worker can continue to grow into positions such as an (all-round) entrepreneur (odd jobs company), work planner or a middle management employee deconstruction technologies or one in technical building installations.	<b>International agreements</b> The profession Constructional maintenance worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.														
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95271 The education and training for this qualification is offered as of August 1, 2010.															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
<b>Average duration of the education/ training leading to the certificate</b>	<b>3 years (4800 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
