- 1.2 Makes colour cards, material samplers, decoration samplers
- 1.3 Develops items for the collection
- 1.4 Puts together the collection
- 1.5 Makes flat technical drawings and style sheets

Core task 2: Directs and assesses the sampling

- 2.1 Delivers item for sampling
- 2.2 Fits and assesses the sample
- 2.3 Registers and passes on the fitting information
- 2.4 Completes the style sheet and size specification from salesman sample

The Styling assistant is qualified to collaborate on a new collection in the departments of design and production preparation in the clothing industry within a (integrated) clothing company.

Access to next level of education/professions Within the company, the Styling assistant can be promoted to head of the patterns department or the department of production preparation, or to the position of stylist. In addition, the Styling assistant can also do a specialist intermediate or higher vocational education programme.	International agreements The profession of Styling assistant is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
