3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Warehouse manager are:

A Warehouse manager plans, organizes and coordinates the activities in the warehouse of a wholesaler's. And sometimes manages warehouse group leaders. What the (core) tasks are of a Warehouse manager depends of the size of the company. In large companies certain warehouse tasks often belong to separate departments. There will be more Warehouse managers, who are each responsible for one or more aspects of the activities in the warehouse (such as reception, storage, order production, expedition). In smaller companies the Warehouse manager is occupied with more aspects at the same time.

5. OFFICIAL BASIS OF THE CERTIFICATE

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
