The main tasks of a Mechanic electrical industrial installations are:

- to install cable installations for industrial installations;
- to modify industrial switching and distribution devices.

The Mechanic electrical industrial installations is responsible for the execution of his set of tasks consisting of the application of automated routines and standard procedures. Because of the varying working situations combining standard procedures and devising procedures within his set of tasks is also applicable. The Mechanis at this level does not carry hierarchical responsibility.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Mechanic electrical industrial installations in general employed in the industry or with electro technical installation engineering contractors and carries out work on and for the purpose of low-voltage industrial installations.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 2 year(s) (3200 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
