5. OFFICIAL BASIS OF THE CERTIFICATE	
The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme. Access to next level of education/professions The Attendant equestrian sports II can advance to Instructor equestrian sports III by developing his own riding skills and his own didactic capacity. The admission requirement is an appropriate level of personal riding skill. The Attendant equestrian sports II has the same level of didactic skills as sports attendants in other sports. If he also acquires technical sporting skills within another sport, it is possible within that sport to hold a position as sports attendant. The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
