3. PROFILE OF SKILLS AND COMPETENCES

Course of study for the qualification Supervisor environmental monitoring. Depending on the organisation where the Supervisor environmental monitoring works, he/she may perform the following tasks: preparing permits, performing supervision of permit holders, providing information, supervising compliance with environmental laws and regulations, advising companies for example on the remediation of contaminated soil and the organisation of company environmental protection programmes.

The teaching programme consists of the following elements:

waste management, performing abiotic measurements, supporting business processes, implementing environmental regulations, managing waste flows, enforcing environmental rules, environmental permit issuing, Dutch, chemistry, foreign languages, social studies, general skills, performing company environmental protection services and performing sampling.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Supervisor (in a management position) at various (government) institutions and companies responsible for the environment, such as provinces, municipalities and water authorities, the environmental police and environmental consultancy firms. Possible positions include: environmental inspector, technical assistant environment, sampler, environmental protection and health and safety at work assistant, environmental information officer, waste substance acceptance inspector, waste dumpsite manager, officer of the environmental police.

<p>Access to next level of education/professions With a diploma at qualification level 4, transfer is possible to higher professional education. For example to Higher Agricultural Education, Higher Agricultural Pedagogical Education and agricultural course education.</p>	<p>International agreements Supervisor environmental monitoring is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
