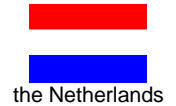

## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Photography worker are:

Core task 1: Producing and adjusting light, image and/or sound

- 1.1 Gathers AV material and equipment, constructs it and takes it down after completion
- 1.2 Connects and adjusts equipment
- 1.3 Optimises the shooting location and/or styles the design and décor
- 1.4 Operates AV equipment during productions and recordings
- 1.5 Selects takes for the processing and/or editing
- 1.6 Revises and/or edits takes

Core task 2: Maintaining and managing AV material and equipment

- 2.1 Checks audio-visual material and apparatus and carries out simple maintenance
- 2.2 Manages the archive
- 2.3 Carries out reception counter work

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Photography worker works in the AV sector, and generally in photographic or related businesses. In many cases he works in a specialist photography store and/or photo studio, but sometimes also for (worldwide operating) stock agencies that sell photographic material from archives. The nature of the photography can vary from public photography (including bridal and portrait photography) via publicity photography (including advertising and fashion photography) to news photography, technical and industrial photography. He can also work in an AV rental company.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).            In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.            In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>            The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
