The task of Electronic planners is to compile and/or process and/or produce digitally and/or conventionally supplied parts or online and offline multimedia products. With this in mind, they must have knowledge of digital technology, communication, database structures and data communication, and be able to apply this knowledge to production. Electronic planners must be able to locate, analyse and solve process disruptions and production problems, and manage and maintain equipment, software and data. Their tasks involve applying and combining standard procedures according to order specifications

An Electronic planner must work accurately, be interested in and be able to deal with computer systems and have to be able to work independently as well as in a team.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
