The most important duties of a Manager fresh food trade, logistics and transport are:

Core task 1: Supervises total product flow

- 1.1 Organises internal transport of products
- 1.2 Formulates plan of division
- 1.3 Monitors the storage conditions
- 1.4 Organises the processing and packaging of products
- 1.5 Organises external transport of products
- 1.6 Registers, inspects and reports about product, storage and transport data

Core task 2: Manages the business section

- 2.1 Formulates departmental plan
- 2.2 Formulates work instructions
- 2.3 Monitors implementation of quality policy
- 2.4 Is responsible for providing information and the development of staff
- 2.5 Monitors and is responsible for the financial situation
- 2.6 Maintains external contacts

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager fresh produce trade, logistics and transport works for a wholesaler that trades and processes food and green products. This includes trading and processing flowers, plants, potatoes, vegetables, fruit, or other living products and/or foods.

Access to next level of education/professions It is possible to switch to the position of business manager or self-employed entrepreneur in another sector, both inside and outside the domain of food and living environment. An example of a relevant higher vocational education programme is Agricultural business administration.	International agreements The profession of Manager fresh produce trade, logistics and transport is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97010 The education and training for this qualification is offered as of August 1, 2009.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
