3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Audio-visual worker are:

The Audio-visual worker carries out above all support tasks, including logistic activities for an assignment or production. This includes collecting, monitoring, transporting and tidying away all necessary AV equipment and material. The Audio-visual worker also assists in installing and operating this equipment and these materials. Wherever possible, he carries out minor maintenance and repairs defects. He carries out his tasks independently, subject to the supervision or the instructions of a specialist.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
