# 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a ICT service worker are:

- assembly of hardware;
- support of system users;
- Installation and maintenance of hard- and software.

The ICT service worker takes care of the well functioning of the personal computer of all the employees of the company/organisation where he or she works. He/she prepares computers to be ready for use and replaces parts that are broken.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

ICT service worker in a public or private organisation. His/her work can be combined either with commercial activities (e.g. in a computer shop) or with technical or administrative activities.

### Legal basis

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
