3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Activity supervisor are:

The Activity supervisor is responsible for the preparation, organisation, presentation and (direct or indirect) supervision of activities for clients from specific target groups, whereby the Activity supervisor creates opportunities and conditions for the client according to method-based treatment. The central focus is the care demand and meaningful daily occupation. Method-based treatment includes social studies-based and instrumental-technical activities. The Activity supervisor works as a team member in many fields of health care, service provision, welfare and sport (care for the elderly, care for the mentally disabled and/or physically handicapped, psychiatry).

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Activity supervisor carries out activities in a wide range of settings, in community, semi-residential and residential work forms.

The Activity supervisor can work in care homes, nursing homes, residential forms for the elderly, the sick and physical and/or mentally handicapped, hospitals, psychiatric institutions, therapeutic communities, day care for former psychiatric patients, asylum-seekers centres, institutions for detainees, children's farms, farms for the mentally-handicapped, etc.

International agreements The profession of Activity supervisor is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
