- 2.4 Offers the child/the youth developmental activities

Core task 3: Carries out organisational and professionally related tasks

- 3.1 Contributes to the improvement in expertise and professionalization of the profession
- 3.2 Contributes to the improvement and monitoring of quality care
- 3.3 Balances the working duties together with those involved
- 3.4 Evaluates the working duties

The Pedagogical child carer 3 works in a day nursery, after school child care centre or a playgroup.

<p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. <p>Access to next level of education/professions With the certificate of professional training, transfer is possible to a middle management or specialist course (qualification level 4). The diploma of Pedagogical child carer 3 gives access to the programmes for Pedagogical child carer 4 and Pedagogical youth carer 4, and other intermediate vocational education programmes at level 4, such as Carer for the disabled, Carer for adults, Socio-cultural worker, Teaching assistant, Social worker, Nurse (general care), or Workplace trainer.</p>	<p>International agreements The profession of Pedagogical child carer 3 is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
