## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Purchaser and salesman fresh produce trade are:

Core task 1: Makes preparations for purchasing or sales

- 1.1 Consults with purchasing and sales team
- 1.2 Maintains external contacts
- 1.3 Provides an up-to-date account of the market
- 1.4 Contributes to the initiating of market initiatives
- 1.5 Follows developments in the sector and adjusts working duties accordingly

Core task 2: Buys products fresh produce trade and sells them

- 2.1 Determines demand from the customer or offer from the suppliers
- 2.2 Tests product

2.3 Negotiates

- 2.4 Makes an agreement with the customer or supplier
- 2.5 Organises packaging and transport
- 2.6 Administers and inspects product, process and transport data
- 2.7 Carries out aftersales
- 2.8 Identifies and deals with complaints

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Purchaser and salesman fresh produce trade works for a wholesaler that trades and processes food and green products. This includes trading and processing flowers, plants, potatoes, vegetables, fruit and other agricultural produce.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions If proven competent, the Purchaser and salesman fresh produce trade, based on training and/or experience, has limited career opportunities to a commercial purchase or sales position (external) within other sectors in the wholesale business. Promotion is also possible to a managerial position within the own sector, i.e., manager fresh food trade, logistics and transport.	International agreements The profession of Purchaser and salesman fresh produce trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97690 The education and training for this qualification is offered as of August 1, 2010.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
