3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Manager recycling centre are:

Core task 1: Keeps public space clean

- 1.1 Does preparatory work for the removal of waste from the public area
- 1.2 Coordinates the work
- 1.3 Removes waste from the public area
- 1.4 Completes the work

Core task 2: Carries out intake, sorting and/or recycling of (small/hazardous) domestic and company waste

- 2.1 Prepares the work
- 2.2 Handles the intake, sorting and transport of (small/hazardous) waste and raw materials
- 2.3 Completes the work

Core task 3: Carries out management tasks

- 3.1 Manages colleagues
- 3.2 Monitors the progress and quality
- 3.3 Is point of contact for residents and clients
- 3.4 Coaches students and new employees
- 3.5 Is point of contact for management

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Manager recycling centre can be contracted by a small, medium and large organisation, including municipalities with their own external service, public companies and/or private companies. These private companies generally work for local governments (municipalities) and for private enterprises to a more limited extent.

A Manager recycling centre carries out tasks at the recycling centre, including those in complex situations. Aside from his management tasks, he also carries out executive tasks himself.

Furthermore, a Manager recycling centre can develop in this sector through courses and training.</p>	<p>International agreements The profession of Manager recycling centre is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
