- 1.4 Cleans up the workplace

Core task 2: Organises the daily working duties of colleagues

- 2.1 Divides up the working duties and instructs colleagues
- 2.2 Divides up the working duties and instructs colleagues
- 2.3 Discusses and comes to agreement with third parties
- 2.4 Monitors the progress
- 2.5 Reports to the manager

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round demolisher is employed by a demolishing company and works primarily on a demolishing location. It could involve total demolition or renovation demolition. The All-round demolisher is often assigned to demolish (parts of) large scale projects, unique projects and complex ones

<p>Access to next level of education/professions The All-round demolisher can develop to positions such as train driver demolishing, executor demolishing works, planner or calculator.</p>	<p>International agreements The profession of Allround demolisher is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
