3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Mechanic ground, road and waterway machinery are:

- To carry out minor and major servicing on excavators, road construction machinery, cranes and foundation Machinery;
- To carry out checks and deal with revision and repair of these machines;
- To diagnose malfunctions and change and adjust machine parts;
- To maintain and repair light materials.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Mechanic, field mechanic, mobile crane mechanic, high-rise crane mechanic.

5. OFFICIAL BASIS OF THE CERTIFICATE

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
