## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic agricultural machinery technology are:

The profession of Skilled mechanic agricultural machinery technology focuses primarily on the technical maintenance of vehicles, machinery and installations for agriculture and horticulture. The focus of the work of the Skilled mechanic is centred on fault tracing, analysis and diagnosis, the replacement or repair of faulty parts and the preparation for use of vehicles, various machines and installations for agriculture and horticulture. The Skilled mechanic operates independently and together with others.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled mechanic agricultural machinery technology is employed in a contract firm or with a maintenance company for the maintenance and repair of tractors, combine harvesters, seed drills/planting machines, threshers, etc., as well as in companies manufacturing and designing these machines.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**3 year(s) (4800 study hours) (depending on previous education)**

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
