#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Primary carpenter are:

- Carrying out adjustment work;

- Producing roofing;
- Laying out construction work;
- Adjusting and installing simple prefab elements;
- Producing concrete foundations;
- Producing dividing walls and ceilings;
- Fitting and hanging doors and windows;
- Carrying out carpentry work;
- Carrying out repair work;
- Carrying out simple mechanical carpentry work.

The Primary carpenter is qualified to carry out most common work processes in civil, office and industrial building, independently or subject to the supervision of a foreman or (assistant) foreman, and can be widely deployed in the industry.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Primary carpenter can work in various positions: contractors and specialised contractors and/or in real estate management organisations.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
