### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Asphalt finishing worker are:

Core task 1: Carries out basic ground, waterway and road work

- 1.1 Sets up and maintains temporary traffic signs
- 1.2 Sets up and maintains work terrain
- 1.3 Takes measurements
- 1.4 Performs preparatory work
- 1.5 Lays hard surfaces
- 1.6 Puts work areas into agreed condition

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Asphalt finishing worker is employed in the ground, road and waterway engineering sector, part of the construction infrastructure industry. He is employed for small, medium-sized and large companies, or as an independent worker without employees.

The Asphalt finishing worker works on an asphalting machine and road rollers. He is part of the asphalting team.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
