3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Coordinator port operations are:

Core task 1: Loads, unloads and transports the cargo for the benefit of the harbour

1.1 Loads, unloads and transports the goods

1.2 Detecht and/or reports deviations

1.3 Detects and acts in case of problems and unsafe situations during loading, unloading and transporting the goods

1.4 Completes the loading, unloading and relocation of goods in the port

Core task 2: Secures cargo and/or transport means and unties cargo and/or transport means goederen to guarantee a damage-free transport of cargo and/or transport means for the benefit of the harbour

2.1 Does preparatory work for safe and damage-free securing and untying of cargo and/or transport means

2.2 Guarantees a safe and damage-free securing and untying of cargo and/or transport means.

2.3 Rounds off the guarantee of a safe and damage-free securing and untying of cargo and/or transport means.

Core task 3: Checks cargo, information and transport means

- 3.1 Checks cargo and transport means
- 3.2 Checks and registers data for the benefit of the loading file

3.3 Inspects and reports damages on cargo and transport means

Core task 4: Coordinates and monitors the operational process for the benefit of the harbour

- 4.1 Prepares the operational process
- 4.2 Makes and monitors the planning
- 4.3 Monitors the progress and manages the execution of the operational process
- 4.4 Registers and reports information relating to the operational process
- 4.5 Takes care of adequate use of machinery, tools and materials
- 4.6 Detects and acts in case of problems and unsafe situations in the operational process

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Coordinator port operations is employed in a bulk transhipment, container transhipment, roro company or mixed cargo company for the benefit of the harbour. This organisation is 24/7 occupied with loading and unloading

Access to next level of education/professions After additional training and/or proven competencies, the Coordinator port operations can rise to higher managerial position such as the position of manager port operations and terminal manager. After this qualification, the coordinator port operations can be promoted to the intermediate vocational education programme for Manager port operations (level 4).	International agreements The profession of Coordinator port operations is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
