The most important duties of an Assistant manager logistics wood trade are:

Core task 1: Receives and stores products

- 1.1 Receives, inspects and registers products
- 1.2 Unloads products and makes them ready for storage
- 1.3 Divides and keeps products
- 1.4 Makes an inventory of the stock

Core task 2: Assembles and prepares products for transport

- 2.1 Gathers and moves products
- 2.2 Carries out VAS activities
- 2.3 Makes wood and sheet materials ready for delivery
- 2.4 Delivers products at external means of transport

Core task 3: Manages

- 3.1 Plans and divides up the logistics working duties
- 3.2 Instructs and supervises working duties
- 3.3 Holds work meeting with the team
- 3.4 Monitors the progress of the logistic process
- 3.5 Monitors logistic means and the warehouse

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Assistant manager logistics wood trade works in the wood trade, where wood and sheet material are imported, stored, processed, and traded.

5. OFFICIAL BASIS OF THE CERTIFICATE

The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education, Culture and Science pupil attended the programme.

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

A diploma at level 4 gives access to higher professional education. Higher professional education programmes such as for Technical business administration, Industrial product design, Human technology and Architecture are the most logical step.

International agreements

The profession of Assistant manager logistics wood trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95350 The education and training for this qualification is offered as of August 1, 2011.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information in section 3 and 4 is drawn directly from the qualification file, that is composed by the Centre of Expertise.
