## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic medium voltage installations are:

The Skilled mechanic medium voltage installations (EMMI) works on installations with considerably higher voltages than normal in domestic installations. Working on medium voltage means working with voltages of up to 25,000 V, usually expressed as 25 kV.

Medium voltage grids for example supply electricity to residential districts, larger companies, office buildings, etc. This means that the Skilled mechanic works on switch and distributor stations, distribution grids and all possible switching installations in industrial applications.

A Skilled mechanic is responsible for implementing his own package of tasks. This package of tasks consists of applying and combining standard procedures and elaborating procedures. He monitors and supervises the application of automated routines and standard procedures by others and in this connection bears hierarchical responsibility.

<b>Access to next level of education/professions</b> With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.	<b>International agreements</b> The profession of Skilled mechanic medium voltage installations is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
<b>Average duration of the education/ training leading to the certificate</b>	<b>3 years (4800 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
