3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Employee sterile medical appliances (Employee SMA) are:

Core task 1: Cleans, disinfects and sterilises reusable medical aids

- 1.1 Plans and agrees cleaning, disinfecting and sterilisation working duties
- 1.2 Cleans and disassembles medical aids
- 1.3 Assembles charges and cleans and disinfects medical aids
- 1.4 Releases cleaned and disinfected medical aids
- 1.5 Inspects, assembles and maintains medical aids
- 1.6 Assembles and packs sets of medical aids
- 1.7 Assembles charges and cleans and disinfects medical aids
- 1.8 Releases cleaned and disinfected medical aids
- 1.9 Monitors technical state of apparatus and stock of materials for use

Core task 2: Manage and transport reusable and disposable (sterilised) medical aids

- 2.1 Assembles and transports reusable medical aids from the client
- 2.2 Carries out entry inspection of disposable SMA
- 2.3 Maintains and monitors quality of stock reusable and disposable SMA
- 2.4 Is responsible for stock of disposable and reusable SMA
- 2.5 Transports reusable and disposable SMA to the client
- 2.6 Carries out recall procedures

Core task 3: Carry out tasks related to profession

- 3.1 Provides information about SMA
- 3.2 Contributes to the improvement in expertise and professionalisation
- 3.3 Contributes to quality care
- 3.4 Deals with complaints to do with (S)MA

He can develop through VET-level 4 educations, such as Nurse (general care).</p>	<p>International agreements The profession of Employee sterile medical appliances is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
