#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Entrepreneur/manager retail trade are:

The Entrepreneur/manager retail trade supervises a small enterprise with 1 to 10 employees. Running a larger enterprise (11 to 50 employees) or a number of small branches requires more managing competencies. To pursue a good policy, the Entrepreneur/manager retail trade draws up a business plan, using all ideas, data and figures which can be of importance. He formulates the complete policy on marketing, sales, buying, personnel and finances. He determines the interior and exterior design of the store and the place and display of the merchandise. The Entrepreneur/manager retail trade is responsible for purchasing the right commodities, at fair prices, in adequate quantities and at the right time. He negotiates with suppliers, and conducts consumer and competitor research. He analyzes the turnover of his business and realizes the desired turnover by taking adequate measures. He also allots time to bookkeeping, stock keeping and personnel administration.

The Entrepreneur/manager retail trade is responsible for an attractive store, which draws the customer's attention and leads him into and through the shop. Social skills are very important to the Entrepreneur/manager retail trade because he deals with different kinds of people. He advises customers and handles complaints, he stimulates and motivates his employees, he negotiates with suppliers and maintains relationships with several institutions and businesses, such as the local authorities, colleague-entrepreneurs, finance corporations and governmental executive agencies.

However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
