| 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE   |   |

| Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).<br>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.<br>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution. |   |
| <b>Average duration of the education/ training leading to the certificate</b>  | <b>2 years (3200 study hours) (depending on previous education)</b> |
| <b>Entry requirements</b><br>The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.  |   |
