3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round tiler are:

Core task 1: Carries out tile working duties

- 1.1 Sets up the workplace
- 1.2 Prepares the bottom workplace
- 1.3 Sets out tiles and makes a division of the area
- 1.4 Glues floor and wall tiles in place
- 1.5 Lays floor and wall tiles in cement
- 1.6 Finishes off the tiling work
- 1.7 Clears up the workplace

Core task 2: Organises the daily working duties of the colleagues

- 2.1 Divides up the working duties and instructs colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Discusses and comes to agreement with third parties
- 2.4 Monitors the progress
- 2.5 Reports to the manager

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round tiler works primarily in new build, renovation and restoration of houses and utility buildings. He is especially employed by related contractors or operating companies. The All-round tiler works both on regular as on more complex tiling.

International agreements The profession of All-round tiler is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo):25116 The education and training for this qualification is offered as of August 1, 2015.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
