3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round skilled ground, road and waterway worker are:

Core task 1: Carries out road and waterway work

- 1.1 Sets up and maintains temporary traffic signs
- 1.2 Sets up and maintains work terrain
- 1.3 Installs and maintains simple groundwater pumping system
- 1.4 Makes cables and wiring safe
- 1.5 Digs up, fills up, raises and closes off the ground
- 1.6 Lays road foundations
- 1.7 Lays and/or repairs sewage pipe constructions and maintains trenches
- 1.8 Lays verges
- 1.9 Sets channels and drains, places road drains and fittings, lays road drainage
- 1.10 Repairs/ renews hard surfaces, road drains, drainage channels and fittings
- 1.11 Lays temporary hard surfaces
- 1.12 Places street furnishings, railings and barriers
- 1.13 Sets up work area at the agreed road

Core task 2: Organises the daily working duties of the colleagues

- 2.1 Divides up the working duties and instructs colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Monitors the progress
- 2.4 Reports to the manager

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round skilled ground, road and waterway worker works in the road and waterway sector. The all-round skilled road and waterway worker works for small, medium-sized or large companies. These companies are mainly active in wet and dry earth works, and in the laying and maintenance of roads and sewerage.

<p>Access to next level of education/professions After training and experience, the All-round skilled ground, road and waterway worker can be promoted to managerial and organizational positions such as planner, planning officer, or operator. The All-round skilled ground, road and waterway worker can enter sector management training and programmes for Supervisor construction, infrastructure and specialised contracting at level 4 in the qualification structure.</p>	<p>International agreements The profession of All-round skilled ground, road and waterway worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93990 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
