## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Mechanic is working in the sector engineering at an installation company that constructs, maintains and modifies installations for gas, water, central heating, ventilation and sewer systems. The job can take place in houses, small utility buildings, mass production of houses, block of flats, big utility buildings (such as hospitals, schools, office buildings).

## 5. OFFICIAL BASIS OF THE CERTIFICATE

### Legal basis

The education and training for this qualification is offered as of August 1, 2006.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
