3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Artist (music) are:

Core task 1: Maintains and organises his own working field

- 1.1 Makes and maintains contacts
- 1.2 Acquires orders
- 1.3 Performs (financial) administrative activities
- 1.4 Contributes to publicity and promotional activities
- 1.5 Creates and organizes small stage presentations
- 1.6 Gives workshops

Core task 2: Prepares the production/performance

- 2.1 Makes a musical work, a choreography or an act
- 2.2 Translates ideas, concept and/or scripts into a production/concrete ideas
- 2.3 Rehearses individually material and own input
- 2.4 Rehearses in groups

Core task 3: Renders the performance

- 3.1 Prepares for the show/production of products
- 3.2 Performs the production or show/delivers the products
- 3.3 Evaluates the performance/products
- 3.4 Performs sound mixing and adjustment

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The performing musician is active on stages, ranging from pop stage to theatre and community centre, plays on the street or in the background at a private, commercial or recreational gathering. Studio work can also be part of the field of activity. The producing musician is primarily active in the studio, as a producer, sound designer, and maker of commission music or as an artist in the electronic music.

<p>Access to next level of education/professions The musician can develop into band leader, producer, composer/arranger, solo-musician, or teacher/coach. Besides, there are other courses within mbo and hbo, for instance, other art courses at mbo level and adjoining hbo courses: <i>Kleinkunst academie</i> (academy for cabaret), teacher trainings for dance, music or theatre.</p>	<p>International agreements The profession of Artist (music) is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90038 The education and training for this qualification is offered as of August 1, 2010.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 years (6400 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
