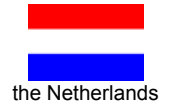

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
<p>In the Netherlands, the piano-technical branch of industry mainly consists of smaller companies. The purpose of such companies revolves around selling, maintaining, tuning, repairing and revising pianos. A Piano technician generally works from within his own enterprise, but can also be employed by a piano-technical company. Aside from private clients, the Piano technician's clients can also include conservatories, theatres and music centres.</p>

<p>Access to next level of education/professions A Piano technician can develop in various ways. He can do courses and workshops in order to further specialise in tuning or repair work. He can also further develop in restoration of pianos and related musical instruments. After spending some time in paid employment, Piano technicians can start their own enterprise. Piano technicians managing their own enterprise can expand their service offer with appropriate related activities, such as rent and/or sale of instruments. In the Netherlands, there are no qualifications on higher VET-levels related to the diploma of Piano technician.</p>	<p>International agreements The profession of Piano technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
