- 1.8 Applies letters/images/ornaments
- 1.9 Tidies the workplace

Core task 2: Organises day-to-day activities of colleagues

- 2.1 Distributes tasks and instructs colleagues
- 2.2 Monitors the quality and checks compliance with instructions
- 2.3 Monitors progress
- 2.4 Reports to manager

The All-round stone mason is employed in a natural stone business, above all working in the workshop but also at cemeteries or on construction sites.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
