The most important duties of a Veterinary nurse are:

Core task 1: Manages reception and pharmacy

- 1.2. Manages animal supplies and medicines
- 1.3. Monitors stocks
- 1.4. Issues information on treatment and after care for the patient

Core task 2: Assists in examinations and treatments

- 2.1. Prepares examinations and treatments
- 2.2. Assists during examinations and treatments
- 2.3. Concludes examinations and treatments.

Core task 3: Assists during operations and coordinates operations

- 3.1. Prepares operations
- 3.2. Administers anaesthetic, under supervision
- 3.3. Assists during operations
- 3.4. Concludes operations

Core task 4: Feeds and cares for healthy animals and supervises reproduction

- 4.1. Makes preparations for food
- 4.2. Is responsible for food and water management
- 4.3. Cares for animals
- 4.4. Monitors animals
- 4.5. Maintains animals
- 4.6. Registers and reports
- 4.7. Supervises reproduction process
- 4.8. Supervises birth process

Core task 5: Is responsible for admitted animals and provides first aid

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
