Core task 2: Prepares the work

- 2.1 Formulates work budget and planning
- 2.2 Buys in capacity, machinery and materials
- 2.3 Draws up safety, health and environmental plan
- 2.4 Sets up reference project
- 2.5 Compiles project team
- 2.6 Passes on the project file
- 2.7 Coaches students

Core task 3: Sets up advice for colour, interior or building

- 3.1 Makes design
- 3.2 Draws up colour and material advice
- 3.3 Supervises implementation
- 3.4 Carries out after-sales activities

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Colour and interior advisor works within either the painting & maintenance branch of industry or the building completion branch of industry. He carries out work for various clients within housing construction, utility construction and industrial construction (the property sector). This involves maintenance, restoration and renovation/construction projects. Generally he works in employment, where he carries out his tasks in a team. He can also work freelance.

The Colour and interior advisor guides clients through the advisory and executive process when it comes to colouring and arranging residential and working areas.

<p><b>Access to next level of education/professions</b> A Colour and interior advisor can develop to become an interior architect through courses, work experience or through the higher professional education Interior architecture. He can also receive further higher professional education through a pedagogical university of technology, where people with a background in construction or maintenance can be trained for higher professional positions within the industry and education.</p>	<p><b>International agreements</b> The profession of Colour and interior advisor is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25012 The education and training for this qualification is offered as of August 1, 2015.</p>																					

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
