3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled commercial vehicle mechanic are:

Core task 1: Carries out maintenance on vehicles or mobile machinery

- 1.1 Prepares the maintenance working duties
- 1.2 Carries out the maintenance working duties
- 1.3 Completes the maintenance work and reports

Core task 2: Carries out repairs on vehicles or mobile machinery

- 2.1 Prepares the repair working duties
- 2.2 Carries out the repair working duties
- 2.3 Completes the repair working duties and reports

Core task 3: Installs accessories, makes adjustments and prepares the commercial vehicle for delivery

- 3.1 Prepares for making ready for delivery and assembly activities
- 3.2 Carries out inspection of commercial vehicle
- 3.3 Makes commercial vehicle ready for delivery
- 3.4 Completes making commercial vehicle ready for delivery

Core task 4: Diagnoses the commercial vehicle

- 4.1 Prepares diagnosis of commercial vehicle
- 4.2 Makes diagnosis of commercial vehicle
- 4.3 Completes diagnosis of commercial vehicle

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Skilled commercial vehicle mechanic works in car company workshops, which are part of the mobility branch. He can be employed by a brand dealer or an independent company. These companies sell new and used commercial vehicles and maintain & repair these vehicles.

International agreements The profession of Skilled commercial vehicle mechanic is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25245 The education and training for this qualification is offered as of August 1, 2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
