3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Cattle pedicurist are:

Core task 1: Takes care of hooves and gives advice

- 1.1 Takes order from client
- 1.2 Investigates animal or herd
- 1.3 Organises the workplace
- 1.4 Carries out preventive hoof treatment
- 1.5 Carries out curative hoof treatment
- 1.6 Completes hoof treatment

Core task 2: Runs a business

- 2.1 Starts up a business
- 2.2 Determines tariffs
- 2.3 Identifies and deals with complaints
- 2.4 Monitors and is responsible for financial situation
- 2.5 Manages business administration
- 2.6 Determines and monitors policy concerning quality, working conditions, environment and safety

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Cattle pedicurist is a service provider in that he takes care of cattle hooves, both preventative and curative.
 The Cattle pedicurist is a self-employed entrepreneur or works for an organization such as the company care.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
