3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Journeyman plasterer are:

Core task 1: Carries out plaster work

- 1.1 Prepares plaster work
- 1.2 Prepares surfaces
- 1.3 Applies roughcasting and finishing layers
- 1.4 Carries out clearing up duties
- 1.5 Delivers plaster work

Core task 2: Carries out decorative plaster work

- 2.1 Applies decorative finishes
- 2.2 Makes and applies frames and ornaments

Core task 3: Carries out practical management

- 3.1 Manages colleagues
- 3.3 Supervises new employees/trainees
- 3.4 Monitors quality and progress of project
- 3.5 Delivers the project

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Journeyman plasterer is primarily employed for companies within the dismantling business sector, specifically within the plasterer sector. He could also be employed as an entrepreneur within the housing construction sector and utility sector (both new buildings and maintenance). Depending on the company, the working duties could be centred on certain types of plaster work. He applies roughcasting and finishing layers to several surfaces (walls and ceilings).

In some cases, The Journey plasterer also carries out decorative plasterwork (decorative finishing layers, mouldings and ornaments).

<p>Access to next level of education/professions The Journeyman plasterer could be transferred to a middle management position (such as executor, entrepreneur) or restoration plasterer. This can happen through, for instance, a training executive position dismantling, maintenance and interior (level 4) or technical courses.</p>	<p>International agreements The profession of Journeyman plasterer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25037 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
